

BUILDING A BRIGHTER FUTURE TOGETHER

Keith Waxelman and Jen Bratton may not be native to Minnesota but there is no question the Twin Cities is where they belong. The couple met in business school and spent the first decade of their marriage in Chicago before a job transfer landed them in Minneapolis.

"We did not have any roots or family here, but we felt instantly at home," said Jen. "It's a very welcoming place. Our kids have essentially grown up here... This is home to them and it's now home to us."

This feeling of belonging is a big part of the reason why the couple is choosing to show up in community, both philanthropically and with their time, in much more meaningful ways than ever before. (The couple and their children are pictured above volunteering at Action Day.)

"We want to leave a positive impact on the community, not just for this generation but for generations to come, to build a stronger future," said Keith.

In addition to being Tocqueville Society members, Keith is a member of the cabinet and Jen is a newly elected member of the Greater Twin Cities United Way board of directors.

Equitable access to education is deeply important to their family. Keith's mother grew up in a small town in the Philippines that had no electricity until around 1985. In pursuit of a better education, she left home at 12 years old to move to the city and live with her aunt and uncle.

Remarkably, she graduated from high school at 16, finished med school at 23, and became a successful cardiologist and pioneer in anti-aging medicine. Her experience inspired her to establish a scholarship to help students from her hometown pursue their own dreams through education. Though his own mother thrived, Keith believes no child should have to leave home to get a quality education.

"Education is something that's really a core value and that's why 80x3 is so important," shared Keith. "The ability to make an impact on a child's early years is so crucial. If they do better, then it's likely that both their family and the community as a whole will do better. So, it's really helping to build bridges to the future in my mind and heart."

After partnering with United Way on a variety of projects through her job at Boston Consulting Group and many years as an active volunteer and donor, Jen is excited to put her operations expertise to use as she digs into her new board role.

"As much as we like to donate and feel lucky and privileged to be in a position in which we can do so, I enjoy getting my hands dirty," said Jen. "I want to solve problems with my mind and hands, not just my wallet."

Jen remarks that Minnesota has the highest per capita concentration of Fortune 500 companies in the U.S. and yet, given all that opportunity and corporate resources, we still have gaps and inequity – whether it be in housing, education or career opportunities – and she and Keith would like to see these gaps bridged.

"Today's world is often so divided, and people forget to look for the common good. Many act like the world is binary – you're either with me or against," said Keith. "But hopefully through programs with United Way, we can act together to try to find that common good again and build a brighter future."

INVESTING IN FUTURE GENERATIONS

Tocqueville Society member and lifelong Minnesotan, Anna Picchetti is driven to make a difference. As a young girl, she spent time volunteering with her aunt, who instilled in her the importance of giving back to community.

Having grown up in a household that relied on programs like free and reduced lunch, nutrition assistance and Head Start, Anna recognizes the value of these supports as an investment in future generations.

"That's what really drives me. It is my privilege and my responsibility to give back knowing what I was given," said Anna.

Today, Anna lives in Minneapolis with her husband and three sons, Luca (10), Holden (8), and Evan (6). Part of the reason she wants to be involved in the community is to set an example for them of the importance of doing our part to build equity.

"Minnesota is a great place to be, but it's not a great place for everyone, and it's on us to be part of creating a more equitable community," said Anna. "I was fortunate to have my aunt and parents as my role models; and I want to be the same role model for my sons."

Like many people, Anna's first introduction to United Way was through a workplace giving campaign early in her career. She recalls that while it was fun to participate in the giving campaigns each year, at the time she didn't realize individuals could get involved in United Way.

Then, a friend invited her to join Women United, a giving group focused on women's financial stability and early childhood education – two causes close to Anna's heart. The experience gave her a deeper understanding of United Way's grantmaking process as well as a broader view of our work.

Anna appreciates Greater Twin Cities United Way's ability to focus attention and resources on strategic opportunities, while investing in those partners closest to the impact to create the most relevant solutions.

Looking to deepen her involvement with United Way and have an even bigger impact on our community, Anna became a member of the Tocqueville Society and recently joined the cabinet.

"It's hard to find like-minded people who are really driven and top leaders, but also very passionate about the community," said Anna. "I'm also pleasantly surprised at how rewarding the experience has been for me personally. It's a great way to give and to fill your cup. It's sort of an investment in your own mental health."
